#### 3.0 COMPETITIONS

#### MAG and WAG QC

Team Final Results.
All-Around Final Results.
Qualification for Mix Pair Final (MPF) and Apparatus Finals (AF)

Each National Olympic Committee can enter a maximum of 3 gymnasts.

A maximum of 3 gymnasts can compete on each apparatus with the 2 best scores on each apparatus counting towards the Team Total.

#### MAG and WAG Mix Pair Final (MPF)

One (1) Male & One (1) Female Gymnast from each NOC.

The scores of the highest ranked AA Male gymnast on FX, PB & HB <u>PLUS</u> the highest ranked AA Female gymnast on VT, BB & FX from the QC will be added together to determine the Total Mix Pair Result for each NOC.

Qualification is by **NAME** and not by NOC.

The Best 16 Mix Pairs will qualify from the QC for the Mix Pair Final

#### MAG and WAG AF

Day 1 - MAG (FX, PH and SR) and WAG (VT and UB)

Day 2 - MAG (VT, PB and HB) and WAG (BB and FX)

The 8 highest ranked gymnasts on each apparatus from the Qualifying Competition will qualify for the respective Apparatus Final.

A maximum number of 2 Gymnasts per NOC are permitted in each Apparatus Final.

3 reserve gymnasts will be named on each Apparatus for each Final.

#### 3.1 The Qualifying Competition (QC)

The starting order of the competition is made in accordance with the drawing of lots carried out at the Chefs de Mission Seminar on 27<sup>th</sup> April 2022 in Banska Bystrica.

If a NOC reduces the number of participating gymnasts or apparatus after the Long & Short List deadlines, the European Gymnastics TCs have the right to modify the Starting Order so as to ensure the best possible running of the competition. All information about the modification of the Starting Order will be advised during the Technical Meeting.



- MAG & WAG Gymnasts will compete independently of each other in Rounds 1 & 2.
- Gymnasts can choose the order on which they compete on the relevant Apparatus, for example:
  - A WAG gymnast may decide to compete on Beam in Round 1 and chose to compete on Vault in Round 2
  - NOC must submit the Order of Apparatus Form for their gymnasts **by 10.00am on the morning of the Competition** via the Sport Information Desk for the attention of:
    - o For the MAG competition to Mr. Tom THINGVOLD, the MAG Technical Delegate
    - o For the WAG competition to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate
- An Apparatus cannot be repeated in Round 1 or Round 2
- If a WAG Gymnast choses to compete on Vault in either Round 1 or Round 2 Only 1 Vault is required.
- At the end of Round 2, the 4 Mix Pairs with the <u>Highest Total Score</u> will qualify for "Round 3 The Semi Finals".

#### **Round 3 – The Semi Finals**

- Group 1 will comprise of the Teams ranked 1<sup>st</sup> & 4<sup>th</sup> at the end of Round 2.
- Group 2 will comprise of the Teams ranked 2<sup>nd</sup> & 3<sup>rd</sup> at the end of Round 2
- No Scores are carried forward from Rounds 1 & 2 (All Mix Pairs start from "0")
- In Round 3, gymnasts must compete on the Apparatus they have not yet competed on.

• The Starting Order in "Round 3 – The Semi Finals" is as follows:

#### At the end of Round 3:

- The 2<sup>nd</sup> placed Mixed Pair in Group 1 will compete against the 2<sup>nd</sup> placed Mixed Pair in Group 2 in "Round 4 The Bronze Medal Final".
- o The Winners of Group 1 will compete against the Winners of Group 2 in "Round 5 The Final".

#### Round 4 - The Bronze Medal Final

- This Round will decide the winners of the Bronze Medal.
- No scores are carried forward from Round 3 (All Mixed Pairs start from "0").
- The gymnasts can choose freely which apparatus they would like to compete on.
- When the Mix Pair Finalists are announced, the concerned NOC must complete Appendix 12 advising what
  apparatus their gymnasts will compete on in Round 4 & submit same to the European Gymnastics Technical
  Delegate within 5 minutes of the Official Announcement of the Finalists (at the end of Round 3)
  - For the MAG competition to Mr. Tom THINGVOLD, the MAG Technical Delegate
  - For the WAG competition to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate
- If a WAG Gymnast choses to compete on Vault in Round 4 2 Vaults are required with Junior Rules applying.
- The Starting Order in "Round 4 The Bronze Medal Final" is as follows:

The Mix Pair with the Highest Total Score at the end of Round 4 will determine the winner of the Bronze Medal.

#### Round 5 - The Final

- This Round will decide the Silver & Gold Medal Winners.
- No scores are carried forward from Round 3 (All Mix Pairs start from "0").
- The gymnasts can choose freely which apparatus they would like to compete on.
- When the Mix Pair Finalists are announced (at the end of Round 3), the concerned NOC's must complete Appendix 12 advising what apparatus their gymnasts will compete on in Round 5 & submit same to the European Gymnastics Technical Delegate <u>within 5 minutes</u> of the Official Announcement of the Finalists (at the end of Round 3).
  - For the MAG competition to Mr. Tom THINGVOLD, the MAG Technical Delegate
  - For the WAG competition to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate
- If a WAG Gymnast choses to compete on Vault in Round 5 2 Vaults are required with Junior Rules applying.

The Starting Order in "Round 5 – The Final" is as follows:

 The Mix Pair with the <u>Highest Total Score</u> at the end of Round 5 will determine the ranking for Silver & Gold Medals.

#### **Tie Break Rule**

- In case of a tie in points at any place to qualify for, or during the Mix Pair Final, the ranking will be determined by respecting the following criteria:
  - 1. The pair with the highest sum of E-Scores across the apparatus in the phase of competition prevails
  - 2. The pair with the highest sum of best single E-Score, one MAG plus one WAG across the apparatus in the phase of competition prevails
  - 3. The pair with the single highest E-Score MAG or WAG across the apparatus in the phase of competition prevails
- If for medical reasons, the best ranked AA Female (on 3 apparatus) / AA Male Gymnast (on 3 apparatus) from the QC withdraws, the second ranked gymnast from the Federation can only replace her / him, if the new Total Score is higher than that of the Federation in 1<sup>st</sup> Reserve.
- All withdrawals should be submitted via the Sports Information Desk for the attention of:
  - o For the MAG competition to Mr. Tom THINGVOLD, the MAG Technical Delegate
  - o For the WAG competition to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate

#### 3.3 The Apparatus Finals (AF)

The Apparatus Finals will take place over two (2) Days.

The starting order for the Apparatus Finals will be in accordance with the draw carried out at the Chefs de Mission Seminar on 26<sup>th</sup> April 2022 in Banska Bystrica.

- In case of a tie at any place in the AF, the tie breaking rules set out in FIG/TR will apply.
- If a qualified gymnast is unable to take part in the AF Competition, then they can be replaced by the next gymnast from their federation, on the condition that their result is better than that of the first reserve. This

- new gymnast will take the starting position of the gymnast they replace.
- Withdrawals / replacements of gymnasts for medical reasons will be accepted provided that the abovementioned conditions are met. They are to be submitted via the Sport Information Desk for the attention of:
  - o For the MAG competition to Mr. Tom THINGVOLD, the MAG Technical Delegate
  - o For the WAG competition to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate
- The general warm-up will take place in the warm-up hall. After the general warm-up, the gymnasts will be permitted to train on the Podium in the Competition Hall prior to the commencement of the Apparatus Finals Competition, on Friday and on Saturday.
- If more than 8 gymnasts qualify for one Apparatus Final, another drawing of lots will take place, to reflect the number of qualified gymnasts. If a gymnast competes in two (or more) successive Apparatus Finals and medals in the preceding Final (thus reducing the gymnasts' opportunity to return to the warm-up hall prior to the next Final), the TD will adjust the start order, if necessary

#### 3.4 Access to the Competition Area

The competition area is accessible to members of the various juries, competing gymnasts and their accredited coaches, to local group leaders, to the auxiliary personnel of the Jury, to the official doctor, to the team doctors, medical staff and to persons concerned with the apparatus as well as the LOC personnel.

Interpreters may not enter the competition area without the permission of the Technical Delegate.

The competition area is strictly forbidden to all other persons.

If a gymnast is not competing on all apparatus, they have the right to leave the competition area and warm-up in the warm-up hall. It is the responsibility of the gymnast to return to the competition hall for their next apparatus. The gymnast should return quietly in their own time.

Concerning the presence of the coaches and medical team on the podium, the following provisions will apply:

Qualifying Competition (QC):

- 2-3 gymnasts Maximum of 2 coaches
- 1 gymnast 1 coach

Mixed Pair Final (MPF) and Apparatus Finals (AF):

• Each gymnast – 1 coach

For all Competitions, 1 team medical person per NOC is permitted.

E-judges may only attend training sessions at which their gymnast / team is in attendance. D-jury (D1- and D2-Judges) may attend all training sessions.

#### 3.5 Use of Electronic Communication Devices

The use of mobile phones or any other electronic communication device by gymnasts, coaches, judges, or medical staff of the delegations on the Field of Play is forbidden during the entire duration of the competition. If this rule is violated, the concerned persons will receive a written warning.

If this behaviour is repeated after the written warning is issued, the concerned person will be excluded for the rest of the competition.

It is the responsibility of the Superior Jury to decide these disciplinary measures and their decision is Final.

#### 3.6 Award Ceremonies

The ceremonies take place immediately after the competition in the competition venue

For Team Competition - 3 Teams on the Podium
 For All-Around Competition - 3 Gymnasts on the Podium
 For Mix Pair Competition - 3 Teams on the Podium

For Apparatus Finals – 3 Gymnasts per apparatus on the Podium

In accordance with the FIG TR, gymnasts are requested to wear NOC track suit during the Award Ceremonies.

#### 3.7 Apparatus Supplier

The apparatus supplier is Spieth.

Additional landing mats for all apparatus will be provided by the apparatus supplier in the warm-up halls and for podium training. In addition, the Federations can bring small protection mats / pads / coverings only. These mats / pads / coverings (e.g. carpet mats, beam protection pad) must not be thicker than 5cm and not bigger than 1.50m x 1m. These mats / pads / coverings can be used during (podium) training but not for the touch warm up.

#### 3.8 Scoring and distribution of Results

After each competition, the results will be provided on the official websites of the EYOF.

All lists and results will be available on the Mobile Application and will also be sent via E-mail and WhatsApp Group to the Delegation Representatives (contact info of the Delegations' Representatives will be collected at the Technical meeting).

Scoring will be carried out by Smart Scoring. A Video Control system will be provided.

At the end of the EYOF, the results book including the Judges' individual scores for all competitions will be sent by e-mail to the Delegation Representatives.

#### 3.9 Technical Meeting

The presence of the participating NOC at the Technical Meeting is mandatory. A maximum of 2 members per NOC per discipline is permitted.

#### 3.10 Competition Numbers

The competition numbers (bib numbers) will be provided to the NOC at the end of the Technical Meeting. The numbers are to be firmly attached to the competition attire throughout the entire competition.

#### 3.11 Written exercises (WAG only)

NOC are more than welcome to submit their gymnasts' exercises in symbol notation. If you wish to do this, we kindly ask that you email these to Mrs. Christine FRAUENKNECHT, the WAG Technical Delegate @ Christine.frauenknecht@bluewin.ch, no later than 24 hours before the commencement of Podium Training.

#### 3.12 New Elements

New elements should be submitted as soon as possible by email to the Presidents of the Superior Jury, but no later than 24 hours before the commencement of Podium Training.

#### 4.2.2 The E-Jury

The placement of the E-Judges on the Apparatus will be decided by the drawing of lots on site. For AF, a NOC whose gymnast has qualified for an Apparatus Final (including 1<sup>st</sup> Reserve) will as a result, not have their judge included in the Judges Draw for the concerned Apparatus.

#### 4.3 Judges' Instruction and Drawing of Lots

According to the European Gymnastics / TR, the presence of the judges at the judges' instruction is mandatory. The judges' instruction will be held in English.

The Judges' Oath will be carried out at the end of the Judges' Instruction, by one of the host Federation's Judges.

#### 4.4 Inquiries of the Score

European Gymnastics applies the TR / FIG and European Gymnastics.

If the inquiry is refused, the amount will be invoiced by European Gymnastics (in Euro, not in USD), at a later date and must be paid within one month.

#### 5.0 THE ORGANIZATION OF THE EVENT

#### 5.1 Training information

According to the Training Schedules.

#### 5.2 Official Podium Training

A detailed program of the official Podium Training will be provided to the participating NOCs.

#### 5.3 Delegations

Each National Federation with 1 or more gymnasts may propose 1 judge to European Gymnastics for approval and nomination.

The Judges must fulfil the requirements of the FIG/TC. All Judges must be holders of a valid FIG Judges Brevet. In case there are insufficient numbers of judges from the participating present NOCs, the Technical Delegates and the Organizing Committee will appoint the necessary number of judges.

Gymnasts who do not have the correct age and a valid FIG license (or the validity of the license has expired) are not allowed to compete. All gymnasts' licenses will be checked by the LOC after receipt of the Long & Short list nominative inscriptions.
