Dear President,

**European Gymnastics is pleased to herein provide you with the Directives for the 36<sup>th</sup> European Women’s Artistic Gymnastics Championships, to be held in Zagreb (CRO) from 13 – 16 August 2026.**

These European Championships will be organised following the FIG & European Gymnastics Statutes and Technical Regulations (TR), FIG Code of Points and relevant newsletters and help desk, FIG General Judges Rules, FIG Specific Judges Rules, FIG Anti-Doping Rules, European Gymnastics Medical Guidelines, the Medical Organisation of FIG Competitions and Events, Policy and Procedures for Safeguarding and Protecting Participants in gymnastics, the FIG Framework for Safeguarding Athletes and other Participants from Harassment and abuse in Sport during Events, the FIG License Rules, European Gymnastics Media Rules, FIG Apparatus Norms, FIG Advertising and Publicity Rules, FIG Rules for Sanctioning (approval) of International Events and European Gymnastics Accreditation Directives, FIG Code of Ethics, FIG Code of Conduct, FIG Code of Discipline, Rules for Award Ceremonies as well as all other Rules and Guidelines valid starting 01 January 2026 onwards, any possible amendments by the date of these European Championships, and any complements decided in the meantime.

All participating Federations commit to abide by the Statutes and all European Gymnastics & FIG Rules and Regulations. National Federations not respecting them will not be allowed to compete.

**Arena Zagreb** is the largest indoor arena in Croatia, officially opened in December 2008. With a maximum capacity of up to 15,000 spectators depending on the configuration, it is a modern multi-purpose venue that has hosted numerous major international sporting events and concerts.

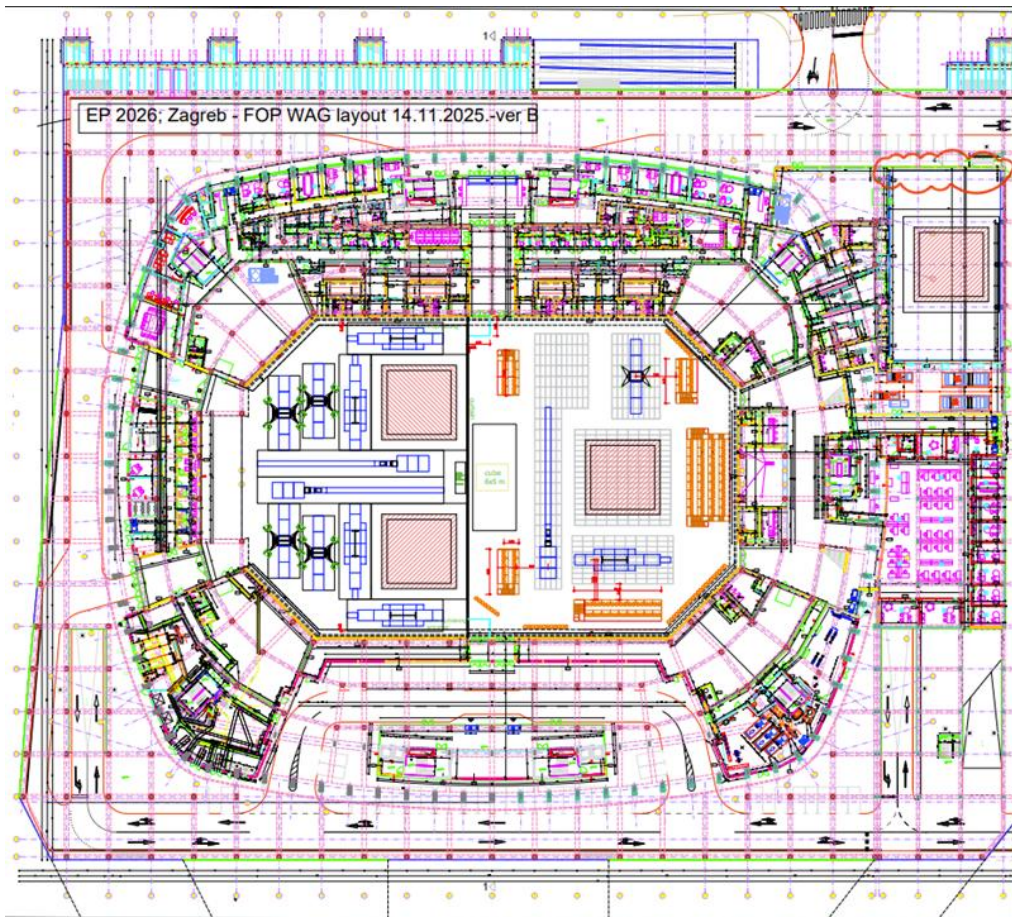
For the European Gymnastics Championships, the arena will be specially reconfigured to accommodate the competition hall, warm-up hall and training hall within the same venue. This integrated setup will ensure optimal athlete flow, operational efficiency, and full compliance with European Gymnastics standards. Due to this tailored layout, the spectator capacity will be adjusted to approximately 5,000 seats.

## 5. PARTICIPATION RIGHT AND ACCREDITATIONS

---

Senior and Junior Gymnasts holding a valid FIG licence until the end of the competitions, and with the correct age from European Gymnastics and FIG affiliated Federations in good standings, may take part in these European Championships. An individual is entitled to only one accreditation card. If an individual has several valid “accreditable” functions, the highest function is normally selected and the access zones of the functions are cumulated. No substitutes may directly benefit from unused accreditations. The functions of judge and gymnast cannot be combined with any other function, except for a gymnast who can also act as Head of Delegation.

### Maximum Delegation Size

---

The maximum size of each delegation, as per European Gymnastics Technical Regulations, is as follows: All federations are entitled to participate with either a team composed of 3 to 5 gymnasts, or a maximum of three (3) individual gymnasts.

Additional accreditations are at the charge of the delegations. The costs of these accreditations are as follows:

The cost for additional accreditations must be paid directly to the LOC. An additional invoice will be sent to the concerned NF, including the bank details of the LOC.

The invoices for the amounts to be paid to European Gymnastics and to the LOC will be available for download on the Gyndata registration platform after submission of the nominative registration.

### Accreditation Application Process

---

Each National Federation (NF) will be invited to submit the accreditation details for each member of its delegation in accordance with the instructions provided by the Local Organising Committee (LOC).

All relevant information regarding the submission procedure and application requirements will be communicated to each NF by the LOC prior to the start of the accreditation application process.

The accreditation documentation must include full personal details for each delegation member (e.g. full name, date of birth, nationality), the appropriate functional role (e.g. Athlete, Coach, Doctor, Team Official), and a digital photograph meeting the specified technical requirements.

The accreditation submission window will open on **14 June 2026** and will close on **14 July 2026**. All completed forms must be received by the LOC no later than the published deadline.

Detailed instructions, including the downloadable accreditation forms, photograph specifications, and submission guidelines, will be distributed to each NF by the LOC following the definitive registration deadline.

The photograph must follow the same requirements as for a passport:

- It must be in **colour**, should be a recent and an accurate likeness of the applicant and must not have been altered in any way
- It should be a **front view of the applicant's face, head and shoulders (facing forward and looking straight at the camera)**; hats, hair bands or dark glasses must not be worn.
- It should show the full head, without any head covering, unless worn for religious beliefs or medical reasons
- With a neutral expression and with the mouth closed
- With eyes open and clearly visible (no sunglasses or tinted glasses and no hair across the eyes)
- No objects, other people or shadows in the photo
- The **background must be plain and light colour, preferably white** but light blue and light grey will be accepted (NO black, dark blue, red etc.)
- Be clear and in sharp focus
- Be taken within the last 6 months

Details should be entered for all participants **until no later than 14 July 2026**. This includes applications for accreditation of additional coaches, paramedical staff and guests for whom the NF will assume the participation costs, as described above.

Please consider: If photos will have to be taken at the accreditation desk (because they were not sent within the deadline/in the correct format) **EUR 50** will be charged for each photo.

All data submitted by NFs via the accreditation platform are subject to the approval of European Gymnastics. The European Gymnastics Accreditation Rules will be strictly applied, notably as far as the number of accreditations per federation is concerned. No further accreditations may be issued. Any additional person is considered a spectator and must buy entry tickets.

Accreditation cards will not be delivered unless all financial and insurance obligations have been successfully completed.

In addition, each NF **must also** register on the **European Gymnastics GymData Online registration system** by the stated entry deadlines for Definitive & Nominative entry (see Point 7).

## Media Accreditations

---

International and local media representatives as well as federations' communication staff who are interested in covering the event can register online through the European Gymnastics website: [Media | European Gymnastics](#).

**Deadline: 30 July 2026**

The European Gymnastics Accreditation Rules and Media Rules have to be strictly respected.

## 6. AGE LIMIT OF GYMNASTS

---

The age of WAG Juniors in 2026 is 14 – 15 years old (born 2012 - 2011), as per the FIG technical regulations.

The age of WAG Seniors in 2026 is minimum 16 years old (born 2010) or older, as per the FIG technical regulations.

Gymnasts who have participated in a Senior World Championships, a Senior Continental Championships, a World Cup / World Challenge Cup, and Multi-Sport Games, may not participate afterwards in Junior competitions.

**All gymnasts must have a valid FIG licence until the end of the event.**

## 7. REGISTRATION AND ENTRY FEES

---

Registrations can only be made by European Gymnastics and FIG affiliated federations in good standing, via the **European Gymnastics GymData Online registration system** from SmartScoring (<http://registry.gymdata.online/>) and by using the National Gymnastics Federations' login and password.

### Definitive Registration

---

The definitive registrations must be completed by entering the composition of the delegation **until 7<sup>th</sup> May 2026 (23:59 Swiss time) at the very latest.**

### Nominative Registration

---

The nominative registrations must be completed by entering the composition of the delegation **until 14<sup>th</sup> July 2026 (23:59 Swiss time) at the very latest.**

Reminder: Together with the nominative registration, delegations must complete their accreditation application via LOC.

**No late registrations will be accepted after the Drawing of Lots** (i.e. the gymnasts will not be allowed to compete), however, a NF who has registered a Team is authorized to add gymnasts to the number declared at the Definitive Registration, up to the maximum quota allowed and upon payment of the late registration fee.

All bank fees in connection with the bank transfer must be covered by the respective Federation. Please state the name of the Federation and the payment purpose on the transfer (i.e. 'CRO\_2026 WAG ECH Registration Fees').

**The payment must be made in EUR only.**

**Please carefully read Appendix 2 -" Payment security for Events"** before making any payment.

Federations which have not fulfilled their financial obligations towards European Gymnastics or FIG (e.g. annual

membership fees, unpaid invoices etc.) and the LOC (e.g. competition fee etc.) will not be allowed to participate in these European Championships.

In case of non-participation or partial participation the fee will not be reimbursed.

## Sanctions

---

The sanctions are as follows as per European Gymnastics /TR (Article 3.2.5)

## 8. LICENCES

---

**No gymnasts will be accredited without a FIG licence valid** until the end of the competitions.

Licence application forms (new or renewal) must be submitted **at least one (1) month prior to the deadline for nominative registration.**

Please consult the FIG licence rules for additional information in this respect.

## 9. JUDGING

---

Each National Federation with a Team or Individual Gymnasts for the Senior or Junior competitions has the obligation to nominate 1 judge. Each National Federation with teams or individual gymnasts for the Senior and Junior competitions must nominate 2 judges.

Note: the D1 judges are considered European Gymnastics' Judges and are not part of the judge's quota of their federation.

NF who are drawn in a D2 position will as a result only be entitled to send ONE / NO judge for inclusion in the E-Panel draw of that competition (the number of judges depends on the number of gymnasts the Federation have competing).

If a federation does not enter a judge or comes with an insufficient number of judges, European Gymnastics, in line with the European Gymnastics Technical Regulations, will request payment in the sum of EUR 5'000.00 per missing judge.

**All judges must have a current valid FIG brevet and category, for their function according to FIG Judges rules at the time of the event.**

Whilst the presence of E-judges at the Official Podium Training is not mandatory, the WTC would strongly encourage all E-Judges to be present at Podium Training.

## 10. DRAWING OF LOTS

---

The gymnasts' drawing of lots will take place after the deadline of the Nominative Registration, on **17 July 2026** at the Head Office of European Gymnastics.

The composition of subdivisions is decided by drawing of lots among the teams and individual gymnasts.

**For Juniors**, the draw will be **open** and will start with the final Subdivision and work its way back to Subdivision 1. As Federations are drawn, they will be placed horizontally across the apparatus working in Olympic order. The draw will continue until all Federations have been drawn.

**For Seniors**, the draw will start with the **4 highest ranked Teams from the Qualification Competition of the previous European Championships plus the Host Federation**, drawn in the final subdivision and placed horizontally across the apparatus working in Olympic order.

The draw will then continue with the remaining teams and individual gymnasts to complete the final Subdivision and then work its way back to Subdivision 1. As Federations are drawn, they will be placed horizontally across the apparatus working in Olympic order. The draw will continue until all federations have been drawn.

## 11. COMPETITION FORMAT

---

The Qualification Competition will act as the continental qualification competition for the 54<sup>th</sup> Artistic Gymnastics World Championships 2026 in Rotterdam, Netherlands. Please refer to Section 2, Article 5 of the FIG Technical Regulations for more details around the rules & continental quotas.

**Seniors - Qualifying Competition including All-Around Final, plus qualification for Apparatus Finals and Team Final**  
**Juniors - Qualifying Competition including All-Around and Team Final, plus qualification for the Apparatus Finals**

A Senior and Junior team consists of 3 - 5 gymnasts, of which up to 4 gymnasts compete on each apparatus.

The 3 best scores on each apparatus are added together to make the team total on that apparatus.

The NF nominates the team on each apparatus.

If a Federation does not have a sufficient number of gymnasts for a full team, it is possible to participate with a maximum of three (3) Individual gymnasts.

A separate All-Around Final result list will be produced to include the 24 gymnasts with the highest ranking obtained. A maximum of 2 gymnasts per Federation will be taken into consideration.

The results from the Senior Qualifying Competition will determine the All-Around Senior European Artistic Gymnastic Champion 2026.

The results from the Junior Qualifying Competition will determine the Junior European Artistic Gymnastics Team Champions 2026 as well as the All-Around Junior European Artistic Gymnastic Champion 2026.

### **SENIORS & JUNIORS - Apparatus Finals**

The 8 highest ranked gymnasts on each apparatus from the Qualifying Competition will qualify for the respective Apparatus Final. A maximum of two gymnasts per Federation will be allowed in the finals.

### **SENIORS - Team Final**

The 8 best Teams from the Qualifying Competition will participate in the Team Final. Teams consist of 3 to 5 gymnasts. 3 gymnasts will compete on each apparatus with all 3 scores counting towards the total score for the Team on that apparatus.

### **RESERVE GYMNASTS:**

For the Apparatus Finals, the following number of reserve gymnasts will be designated, by taking into account the respective Apparatus ranking results in the Qualification Competition:

- Three (3) gymnasts per apparatus

If called upon, a reserve works in accordance with the order of the gymnasts replaced. Reserves must be prepared to compete and must be present in the warm-up hall in case they are called upon.

The provisional training, warm-up and competition schedules will be included in the Work Plan.

## 12. PRIZE MONEY

---

A **prize money** fund will be introduced for the **first time in history** at the **European Championships Zagreb 2026**.

The total prize money fund for **Men's and Women's Artistic Gymnastics** amounts to **EUR 150,000** and is provided exclusively by the LOC – **Croatian Gymnastics Federation**.

The prize money is intended for **athletes and their coach**.

**Prize money** will be awarded in the **Senior All-Around and Apparatus Finals** competitions in both **MAG and WAG**.

The total Prize money for WAG is EUR 62,500 and is detailed in the tables below.

The Prize money, free of any deductible taxes, will be distributed in EUR as follows:

### **Athletes' prize fund per competition: EUR 10,000**

If after application of the tie-breaking rules as outlined in the FIG Technical Regulations, Section 2, there is still a tie, the prize money of the tied ranks will be added and divided equally amongst the respective gymnasts.

### **Coaches' prize fund per competition (1 coach per gymnast): EUR 2,500**

Prize money will be transferred to the bank account of the respective Federation of the awarded gymnast/coach. The LOC will not be responsible for any local taxes payable in the beneficiary's residence country.

## 13. EQUIPMENT

---

The Manufacturer Supplier will be **Spieth** Gymnastics. Please refer to Appendix 1 for the complete List of Apparatus which will be used, including the certified product names and article numbers.

## 14. PUBLICITY

---

FIG advertising and publicity rules must be respected.

The Code of Points outlines deductions should the FIG rules for Advertising and Publicity on attire and equipment not be respected. Each Federation may fill in the online FIG Publicity form if deemed necessary and send it to European Gymnastics by **14<sup>th</sup> July 2026** at the very latest in order to have it approved.

## 15. VISA

---

Please verify immediately with your travel agent or the Croatian Embassy or Consulate in your country if a visa is required for your travel to Croatia. The Organising Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before **7 May 2026** to the following email address: [delegations@echzagreb2026.com](mailto:delegations@echzagreb2026.com)

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.

## 16. TRANSPORTATION

---

**European Gymnastics and the LOC strongly recommend that each Federation take cancellation insurance for their travel.**

### International Transportation

---

The invited participating Federations must pay for the travel costs of their delegation members.

The official arrival airport is:

- **Franjo Tuđman Airport, Zagreb (ZAG)**

You can also arrive at Zagreb Railway Station by train or Zagreb Bus Station by bus.

All accredited persons who have booked an official Zagreb 2026 competition fee package through the Zagreb 2026 LOC will be provided with complimentary transfers from and to Franjo Tuđman Airport, Zagreb, as well as Zagreb Train Station and Zagreb Bus Station, on the official arrival and departure days.

These transfers will operate between the designated arrival points and the official hotels, and vice versa, for all accredited persons.

Transportation to and from the airport on days other than the official arrival and departure days will be subject to a transportation fee of EUR 50 per person (one-way).

## Reservations

The following steps must be followed to book the official hotels:

The Host Federation, the Organizing Committee, European Gymnastics and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.

The European Gymnastics and FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.

The FIG insurance IMSSA (International Medical & Security Sports Assistance) **for gymnasts and judges** with a valid FIG License / Brevet is valid for these European Championships. Please see further information on the FIG Intranet. Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to <https://www.gymnastics.sport/site/pages/medical-insurance.php> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.

**All other delegation members are NOT included in this insurance and must present a proof of insurance at the accreditation.**

The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy in English writing).

Delegation members with insufficient insurance coverage will subsequently be offered with insurance at the Federations own charge as follows: **EUR 15** per person/day.

## 22. WORK PLAN

---

European Gymnastics will endeavour to issue the Work Plan to Federations and other persons concerned six weeks prior to the start of the competition.

## 23. DOPING CONTROLS

---

Doping controls will be organised by the International Testing Agency (ITA) on behalf of the FIG and according to the World Anti-Doping Code (WADC), the international standards enacted by the World Anti-doping Agency (WADA) and FIG Anti-Doping Rules.

## 24. SAFEGUARDING

---

A safe environment for all participants is a top priority at the 2026 European Championships. In case you experience or see any form of non-accidental violence, harassment and abuse please contact Ms Lisa Worthmann ([lworthmann@europeangymnastics.com](mailto:lworthmann@europeangymnastics.com)).

From the **official day of arrival** until the **official day of departure**, all participants — including **gymnasts, coaches, judges, and other Delegation Members** — will have the possibility to **contact the LOC Safeguarding Officer** by phone or email in case of:

- Harassment
- Abuse of any kind
- Any situation where they feel uncomfortable or unsafe

The **contact information** for the LOC Safeguarding Officer will be **provided to all Delegations upon arrival** on site.

## Security for event related payments

An increase in fraud with event-related payments was seen recently. (Fraudulent bank details being shared in hacked e-mail conversations and payments getting lost through that.)

**Please take good note of the below and inform any person involved in administration for participation in European Gymnastics events.**

Please

- **always make sure that an e-mail or link is really coming from the LOC or European Gymnastics** (by verifying each letter of an e-mail address / url).
- **only pay to bank details included in event directives** (published on the European Gymnastics website).
- **never accept new bank details by e-mail** for a payment.
- **if anything looks suspicious** (different bank details on different documents / bank details not matching the event host country (for payments to a LOC) / not matching Switzerland (for entry fees payments to European Gymnastics) / different tone of an e-mail text / different e-mail signature) – **do not pay, but contact the LOC or European Gymnastics separately** via known contact details to verify the situation.

For **all persons handling administration for event participation:**

- **regularly change e-mail account passwords**  
(of *your federation's general e-mail address* and *e-mail accounts of all persons involved in event administration*).
- **never work from an open** (not passport-protected) **wifi-net** (in hotels / event venues / airports / trains etc.). Especially not when logging into e-mail account, bank account or online booking- / event- registration- platforms.
- take care of internet security (**always up-to-date firewall, antivirus programme**).
